**Pool Registration Information**

Long time residents know that for one of those annual rites of spring in Newington Forest is pool registration. If you plan on spending some time by the pool this summer you will need to either register to use the pool or update your pool registration in May. All residents who plan to use the pool must have current pool passes to gain admittance to the pool during the pool season.

Residents with passes from a previous year should check the section entitled *Express Pool Registration* to see if they qualify. Residents needing a new picture or those whose passes don't have bar-codes or the year 2009 on the front will need to plan on attending one of the registration sessions noted below.

Residents new to the community, or those who have not registered to use the pool before, will need to attend one of the registration sessions noted below. You will need to bring along all the family members who live in the house so that each new pool member can have their very own pass made. Pool passes are needed for children beginning at age one.

***Express Pool Registration: Do You Qualify?***

In order to qualify for *express* registration you must meet all of the following criteria:

you must have pool passes from a previous year;

pool passes must have a bar code and be imprinted on the front with the year 2010;

no one in the family needs a new pass (children turning 1, 5, 13 & 16 by 8/1/10 will need a new pass);

renter's must provide, along with the pool registration form, a letter from the property owner turning over their pool privileges;

the property assessment account must be up to date; and

there can be no outstanding covenant violations for your property.

If you meet all of these criteria you can use the *express* pool registration and fill out the form. You can mail your form, no passes, to the Association Office at 8201 Southrun Rd., Springfield, VA. 22153, or drop it off at the Association Office, by no later than April 30, 2010. You must provide an e-mail address in the space indicated on the form to receive acknowledgment of your registration.

**Don't Qualify for *Express* Registration?**

Have no fear we will still be conducting regular registration beginning May 8<sup>th</sup> and continuing through May 15<sup>th</sup> as shown on the schedule below:

Saturdays

May 8<sup>th</sup> 12 p.m. - 3 p.m.

May 15<sup>th</sup> 10 a.m. - 3 p.m.

Monday through Friday evenings

May 10<sup>th</sup> - May 14<sup>th</sup> 7 p.m. - 9 p.m.

Wednesday through Friday Mornings

May 12<sup>th</sup> - May 14<sup>th</sup> 10 a.m. - 12 noon

Please be sure to register to use the pool by no later than May 16<sup>th</sup> using either the *express* registration process or coming by during the week of pool registration.

Residents who choose to wait until after May 16<sup>th</sup> to register for the pool will be charged a late registration fee.

**Pool Pass Photo IDs**

Pool Pass photo IDs will be made during regular registration. The cost for a new pass is \$2.00. Children who have moved to an older age group must have a new ID photo taken. For the purposes of pool registration a child's age as of August 1, 2009 is the determining factor in whether a new pool pass is needed or not.

**Want to use the Pool Memorial Day Weekend?**

Please be sure that you register to use the pool by May 15<sup>th</sup> as we will be unable to process late registrations until after the pool opens on Memorial Day weekend. If you don't register by May 15<sup>th</sup> you will be unable to use the pool over the Memorial Day weekend.

**Are you a Tenant in a Property?**

If you are renting a property in the community you must supply NFCA with a current statement from the property owners transferring their pool privileges to you in order to complete the registration process. Even if you don't have this statement in hand be sure to register on time so that you don't have to pay the late registration fee.

Children ages 8-12 must be able to swim one and a half laps of the pool, tread water for one minute, and be able to float to qualify as a swimmer. Parents who wish their children to enter the pool unaccompanied must arrange with the lifeguards for their children to take the swim test **each year**. Children 8-12 years old who have not passed the swim test given by the lifeguards must be in the company of an adult, or sibling age 13 or older, who will be responsible for the child at all times.

**TERMS OF AGREEMENT:** Pool passes are available to Newington Forest Community residents only and are non-transferable. Use of the Newington Forest Community Association pool is restricted to residents of the community and their paying guests. **Providing false information on this form regarding the resident status of any person will result in the loss of pool privileges for the entire family for the summer.**
